## Promotion Name: 'MEGA Member's Money'

NSW Permit Number: LTPS/19/33149

**Total number of prizes in NSW: 8 per month** (Based on 8 x \$2,500 wins each 4 week period)

**Total value of prizes in NSW: \$360,000** (Based on \$5,000 per week + 4 x cars @ \$25,000 each quarterly period)

### Promotional Period

1. MEGA Members' Money' Promotion ("Promotion") commences at 4.00pm (**first draw**) on **Saturday 6 April 2019** and **ends Thursday 26 March 2020 (52 weeks)**, after the final MEGA draw.

### Entry Requirements

2. Entry is open to all financial members of the club.
3. A member's financial membership number will be randomly generated through the electronic Konami membership program and announced over the Club's PA system.
4. Member's (winners) must be present in the club and will have four (4) minutes to claim their prize. If won, there will be no further scheduled draws for that day. If the member is not present, the amount remains unclaimed and the next scheduled draw takes place.
5. All winners in this promotion are **unique**, meaning once a winner has been drawn and claimed their prize, they are not eligible to win again within the same scheduled draw, this includes the MEGA Cash and Car Draw.

### Weekly Draws and Prizes

**6. Weekly draws will be conducted every Saturday at 4.00pm, 5.00pm, 6.00pm and 7.00pm and Thursday at 6.00pm, 7.00pm, 8.00pm and 9.00pm.**
